- **4 WAY FORMATION SKYDIVING**
- **4 WAY ROTATIONS CANOPY FORMATION**
- **2 WAY SEQUENTIAL CANOPY FORMATION**

This Competition is open to members and organizations of the ASIANIA Parachute Federation. THERE IS NO ENTRY FEE.

This type of competition is intended to attract all levels of Competitors and Judges. It aims to assist and encourage the improvement of competitive skills in the disciplines of 4 Way Formation Skydiving, 2 and 4 Way Canopy Formation.

GENERAL RULES FOR 9th ASIANIA "EMAX" VIDEO COMPETITION

EVENTS: 4 Way FS – 4 Way Rotations CF – 2 Way Sequential CF

FAI Sporting Code rules 2012 will be followed for judging assessments.

1. **TEAMS:**

- *A maximum number of two (2) teams per event may be entered from each country.
- *Teams do not necessarily have to be an official National team.
- *The first two (2) teams per event per country to send their registration form will be accepted.
- *5 Team members for the 4 Way FS and CF events
- *3 Team members for the 2 Way CF event.

2. **JUMPS:**

- *Each competition event will consist of three (3) jumps, with all jumps to count for scoring.
- *Team can practice each jump as many times as they wish
- ***Only one (1) official entry per team is permitted.**
- *A Team will be required to submit the three (3) official jumps for the selected event on one (1) DVD.

3. **JUDGES:**
 - *All Judges are encouraged to judge their team and to submit their judging score and comments for each official jump.
 - * Each Judge will receive a personal critique of their judging score if requested, as an aim to improve and assist judging ability,
 4. **JUDGING:**
 - *Internet judging will be carried out by official approved FAI Judges selected for each event.
 5. **AIRCRAFT:**
 - *Aircraft is the preferred selection of each team
 6. ***Teams will have five (5) months to complete the competition jumps.**

Because ASIANIA covers such a broad spectrum of countries this extended time is allowed to enable every country to be able to participate during their most suitable weather and convenient time.
 7. ***Teams will require authorization by the Officer in Charge or Chief Instructor or FAI / National Judge verifying that the Video Entry is the nominated team and team members.**
- **DRAW SEQUENCES from the FAI Sporting Code Dive Pool 2012 for the three (3) competition jumps FOR EACH NOMINATED EVENT will be sent via E-mail by the 31 May 2102 and published on the Asiania website www.asiania.org as soon as possible**

- **9th ASIANIA "EMAX" VIDEO COMPETITION OFFICIALLY CLOSES ON 31 OCTOBER 2012.** Entries not received by this date will miss out.
- **AWARDS**

ASIANIA Medals will be awarded for the first three placings in each event.
All teams will receive an ASIANIA Certificate of Participation.
