This Competition is open to members of the ASIANIA Parachute Federation.
THERE IS NO ENTRY FEE.

This type of competition is intended to attract ALL LEVELS of Competitors and Judges.
It aims to assist and encourage the improvement of competitive skills in the disciplines of Skydiving and Parachuting.

GENERAL RULES FOR 14th ASIANIA "EMAX" VIDEO COMPETITION

1. **EVENTS:** 4-way FS (Open /female) 2-way & 4-way Sequential CF 4-way Rotations CF
FAI Sporting Code Competition Rules 2017 will be followed for judging assessments.
2. **TEAMS:**
 - *A maximum number of two (2) teams per event may be entered from each country.
 - *The first two (2) teams per event per country to send their registration form will be accepted.
3. **JUMPS:**
 - *Each competition event will consist of three (3) jumps, with all jumps to count for scoring.
 - *Teams can practice each jump as many times as they wish
 - *Only one (1) official entry per event per team may be submitted.
 - *The official entry must contain the three (3) official jumps for the event.
 - *Team will be required to submit the three (3) official jumps for the selected event on DVD or via You Tube or similar media (more details to be notified in Bulletin 2).

4. **JUDGING:**

*OFFICIAL JUDGING WILL BE CARRIED OUT BY APPROVED FAI JUDGES SELECTED FOR EACH EVENT.

*Judges from each country are encouraged to judge their team's performance and to submit their judging assessments and scores for each official jump. Judge Forms are available on request.

*Each Judge will receive a personal critique of their judging assessment if requested, as the aim is to provide competition judging experience and improve judging skills.

5. **AIRCRAFT:**

*Aircraft is the preferred selection of each team – **YOUR choice, YOUR Drop Zone**

6. ***TEAMS will have SIX (6) months to complete the competition jumps.**

Because ASIANIA covers such a broad spectrum of countries this extended time is allowed to enable every country to be able to participate during their most suitable weather and convenient time.

7. ***Teams will require authorization** by the Officer in Charge or Chief Instructor or FAI / National Judge verifying that the official Video Entry is the performance of the nominated team and team members.

8. **DRAW SEQUENCES from the FAI Sporting Code Dive Pool 2017 for the three (3) competition jumps FOR EACH NOMINATED EVENT will be emailed to all ASIANIA organisations and also published on the ASIANIA website www.asiania.org** (see 14th ASIANIA Emax Competition 2017 page)
